V. <u>OLD BUSINESS:</u>

A. Nexus Renewables:

- Nexus still expecting to receive National Grid's approval of the interconnect in 3rd quarter of 2023.
- Once interconnect approval is received, Nexus will obtain quotes to construct solar project.

IDA DISCUSSION:

B. Winstanley Enterprises Project:

1. Tryon Electric Service:

- NG is currently implementing a project that will bring an additional 7-8 MW of distribution level power to Tryon. That project should be done in the 4Q of '24 or early '25.
- NG has said that if a company wants to move to Tryon and it needs 13.2 kV distribution level power, NG is obligated to provide that power at their cost.
- WE will rely on the 7-8 MW of additional power NG is bringing to Tryon. If WE is successful in attracting companies to Tryon that would use all of this 7-8 MW of additional power, WE would then rely on NG to bring more distribution level power to Tryon. This approach will limit WE to only working with companies that need 13.2 level of power or less.
- WE is also exploring incorporating co-generation into future projects to generate the additional power needed that was not available from NG's 13.2 service.

C. Back-up Generator Project:

- Punchlist was prepared and submitted to Koval.
- Once punchlist is complete, final payment will be processed.
- At August meeting, the Board authorized installing an Uninterrupted Power Supply (UPS) on the sewer pump and changing some programming on the pumps to allow them to automatically restart when the generator shuts off.
- UPS has been ordered.

D. Vireo Health Project:

- 1. Sales Tax Exemptions:
 - a) On July 13, 2021, the IDA Board approved granting up to \$2,251,520 in sales tax exemptions.

- b) On August 9, 2022, the IDA Board authorized increasing the total sales tax exemptions available from \$2,251,520 to \$3,284,534 contingent upon Vireo signing either a standard Lease or an Agent and Equipment Lease.
- c) On May 9, 2023, the IDA Board authorized extending from May 31, 2023 to October 31, 2023 the deadline for using sales tax exemptions. This approval was granted contingent upon Vireo signing an Agent and Equipment Lease and paying the balance of the Administrative Fee owed the IDA.
- d) To date, the Lease has not been executed.

Business Marketing / Business Leads / Business Inquires

1. CRG's Countywide EPA Assessment Program:

EPA approved the work plans for Phase 2s on Fashion Tanning and Skip's Garage.

The Phase 2 for Fashion Tanning is planned to begin the week of September 18. CRG will send out a notice to the Brownfield Taskforce Committee and members of the County's Economic Development Committee.

Still working with the Village of Broadalbin town officials on the Korkay Property.

Waiting for EPA regarding the solicitation for Technical Assistance Grants to be used for planning work using a consultant to create conceptual site plans for advancing the redevelopment on Phase 2 properties.

- 2. CRG received one site RFP for a project called Project Aristotle. Fulton County did have an appropriate shovel ready site.
- 3. As part of the NY Loves Nanotech, we recently arranged for some Fulton County organizations to potentially be included as NYS Industry Assets and Academic/R&D Assets.
- 4. The Northern Borders Grant Application for CRG's Johnstown Commerce Park on Rt. 30a project was not successful.
- 5. HUD approved our Release of Funds Request for the Johnstown Commerce Park site purchase.
- 6. CRG sold the Leader Herald Buildings on August 31. The buildings were purchased by ABX/Samco Manufacturing who plan to develop sewing operations in Gloversville.

We worked with ABX/Samco Manufacturing on two grants that were funded. The grants had a combined value of approximately \$400,000, which will go toward equipment purchases.

By invitation of the EPA, CRG recently attended the EPA National Brownfields Training Conference in Detroit.

EPA Region 2 conducted a training session at the conference and CRG was asked to present as part of the Mohawk Valley Brownfield team. We spoke on Fulton County's brownfield efforts through the EPA. There were about 70 people in attendance including the EPA Region 2 Team and their Washington DC counterparts.

- 7. The Mohawk Valley Brownfields Developer Summit is returning for a third year. CRG is one of the leads of the Summit and has already participated in the last four planning team meetings. The event will be held at Herkimer College in the spring of 2024.
- 8. The City of Gloversville Loan Fund Committee approved a loan for a start-up, Timeline Diesel. The amount of the loan was \$60,000.
- The application CRG received through the Six-County JDA Agriculture Loan Fund is still moving forward. We did a site visit and received additional information needed to further review the loan request.
- 10. CRG's Gloversville Downtown Development Specialist continues to work with DRI project awardees. Currently working with eight private DRI projects supporting them through their steps. Several have gone before the local planning board and are completing environmental reviews.

GRIP Grant program, established through the DRI, has nine provisional awardees. The State will give final approval to them after detailed scope of work and environmental reviews are complete. A GRIP Project Developer meeting will be held Sept. 11 to discuss the steps in the process.

The GDDS continues to assist Downtown businesses and recently held ribbon cutting and promotional events for Color Coven INK and the Palace Diner.

Also working on assembling resources including a contractor list for developers, compiling developer packets, and financing and bank lists for businesses
